Summary of Proposed Bylaw Change

Establish a standing bylaws committee. I had previously submitted a bylaw on this but had a few tweaks and changes to make. I was advised to resubmit the bylaw in full.

What Section(s) Does the Bylaws Change Involve?

- Section IX - Bylaw Amendments

Detailed Reason for Change(s)

State Central Committee meetings often go on for very long extended periods of time causing great frustration for large portions of the participants in the room, often times to the point of becoming counterproductive. Many times, it's as a result of an excessive number of amendments introduced from the floor of the body. Many of these amendments could be avoided by having a second set of eyes, like a committee, assist in editing drafts to the proposed bylaws to help ensure they are ready for primetime before moving to the body as a whole. The committee would also help weed out and/or combine duplicate proposals. It would also give the committee the ability to pass proposed bylaw amendments and resolutions to the body with their recommendation for passage. It would also give the committee the ability to kill proposed bylaw amendments or resolutions that may be duplicates or haven't been as well thought out yet, however, even if the bylaws committee would decide to kill a proposed bylaw or resolution if could still be placed on the agenda at the next State Central Committee meeting by a reasonably achievable threshold of a one-third vote. Also, if the committee can't come to a consensus on a proposed bylaw or resolution it gives the committee the ability to send it to the body with no recommendation where it would only need one-fifth of the body to place it on the calendar. It also lays out the makeup of the committee in the same fashion as it's currently made up - by appointments by the Chair and the Regional Directors and when proposals need to be submitted by. This would also ensure that all proposals don't end up sitting on the sidelines for years and ensure they are all given a hearing.

- B. Bylaw Committee Recommendations:
1. Do Pass - A proposed bylaw amendment receiving a "Do Pass" recommendation from the committee shall be placed on the agenda for the next regular or special meeting.
 2. Do Not Pass - A proposed bylaw amendment receiving a "Do Not Pass" recommendation from the committee shall be considered killed and not placed on the agenda for the next regular or special State Central Committee meeting. A proposed bylaw amendment killed by receiving a "Do Not Pass" recommendation from the committee shall be placed on the agenda only if a calendaring motion receives a vote of one-third of the members present at the next regular or special State Central Committee meeting.
 3. No Recommendation - A proposed bylaw amendment receiving "No Recommendation" from the committee shall be placed on the agenda only if a calendaring motion receives a vote of one-fifth of the members present at the next regular or special State Central Committee meeting.
- C. Final Disposition: Final disposition on a proposed bylaw amendment requires a majority vote of the members present taken by roll call.
- D. Proposal Submissions: Proposed bylaw amendments shall be submitted in accordance with Section IX, §1, and not less than ninety days prior to the meeting in which it shall be considered.
- E. Organization:
1. All Bylaw Committee Members are voting members.
 2. The committee shall be registered Republican voters made up of:
 - a. The Chair of the Bylaws Committee shall be appointed by the Chair of the South Dakota Republican Party, after the first meeting of the State Central Committee held every odd numbered calendar year.
 - b. The Members of the Bylaws Committee shall be appointed by the six Regional Directors, one member from each region appointed by their respective Regional Director.
 - c. Odd numbered regions shall appoint after the first regular (winter) meeting of the State Central Committee held every odd numbered calendar year, and even numbered regions shall appoint after the first regular (winter) meeting of the State Central Committee held every even numbered calendar year.
 - d. Bylaw committee members serve for a term of two years, and at the pleasure of the officer that appoints them.

F. Vacancies:

1. Chair vacancies shall be filled by appointment by the Chair of the South Dakota Republican Party.
2. Member vacancies shall be filled by appointment of the respective Regional Directors in which the vacancy occurs.

Summary of Proposed Bylaw Change

Establish a permanent bylaws committee and describe its composition, duties, and integration into the amendment process.

What Section(s) Does the Bylaws Change Involve?

- Section I - State Central Committee

Detailed Reason for Change(s)

Responsibility needs to be formally assigned to maintain the quality and integrity of the SDGOP Bylaws. The bylaws, in accordance with SD state law, constitute the governing document of the SDGOP. Per Roberts Rules of Order, the bylaws of an organization should prescribe its primary characteristics, how it functions, and the rules that are considered so important that a large majority vote is required to change them. These rules delineate organizational purpose, membership, hierarchical structure, positional turnover, duties and limitations, and other important functions, including how to amend the bylaws. At present no entity is assigned to maintain this most important document. A permanent bylaws committee is necessary to ensure the integrity of the bylaws. This would involve using clear, concise language and avoiding excessive detail, which surely leads to excessive amending. It involves clean-up of conflicting and/or redundant provisions, and consistency with state law and RNC rules. It involves the development of standards and guidelines for submitting amendments, to assist the authors who write them. The amendment process should improve the bylaws and organizational functions, not harm them.

The current process of amending the bylaws is poor and, without intervention, will eventually result in inferior bylaws. A permanent bylaws committee can fix this process. Amendments can now be dumped on the State Central Committee (SCC) 15 days prior to any meeting without prior vetting of quality, accuracy, and completeness, and often without full sentences describing the reason for change. Bylaws should not be cluttered up with minute procedural details which should be contained in lower-level documents that are easier to change, often called "procedures." The bylaws committee will work with authors to improve the quality of deficient submissions, and will forward amendments to the SCC with a quality assessment and an appropriate recommendation. Scheduled time must be inserted in the process to allow the above vetting to occur, as well as for the voting members of the SCC to adequately review amendments. Better quality amendments will bring order and clarity to the process of voting on them.

The appointment of the bylaws committee chairman and other members should follow a process that identifies and recruits the bylaws committee members with the applicable experience, skills, and specific interest that would best serve the committee's functions. Certain traits come to mind in prospective members: English language and writing skills, detail oriented, logical thinker, organized, previous bylaws experience, word processing skills, managerial experience, teamwork oriented, registered Republican voter, to name a few. Although the state chairman normally appoints all committee members, the burden of searching for the most appropriate bylaws committee members, beyond its chairman, will benefit from requiring the assistance of the regional directors to appoint the others. However, the agenda of the appointed members is not to represent a region, but to ensure the quality of the SDGOP bylaws. Finally, the bylaws committee will need to develop processes, guidelines, and an attitude of teamwork which will not be fostered by constant turnover. Specified "terms" are

unnecessary. The state chairman can consult with the bylaws committee chairman and the regional directors as necessary when vacancies need to be filled or a committee member is not performing. No elaborate process needs to be invented to accommodate change in committee personnel.
